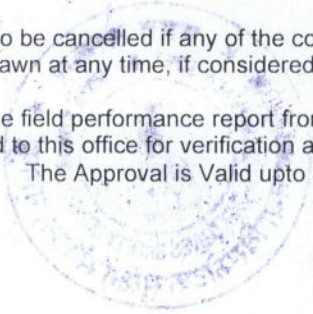
- 1)The design and construction of the equipment shall be strictly in accordance with description, condition and drawings as mentioned in the Intertek Test Reports referred to above.
